### **DEADLINE OF JUNE 25, 2020 TO FILE PROOF OF CLAIMS BASED UPON UNFULFILLED PRE-NEED CONTRACTS**

**Any person who is a party to a contract or has outstanding rights under an unfulfilled Preneed Contract with any of these Entities whereby any of these Entities agreed to furnish funeral merchandise or services in the future (a “Pre-Need Contract”) must file a Proof of Claim with the Clerk of the Bankruptcy Court at the Sam M. Gibbons United States Courthouse 801 North Florida Ave., Suite 555, Tampa, FL 33602 on or before JUNE 25, 2020. Failure to timely file a Proof of Claim may adversely affect your rights and ability to receive a distribution, merchandise, or services.**

The Proof of Claim needs to contain the name and address of the claimant and, if possible, a copy of the Preneed Contract. It is also recommended that the Proof of Claim contain the Claimant’s email address and daytime phone number if available.
